REVIEW OF YOUR APPLICATION

1. The Elkhorn Police Department will perform a background check.
2. If there are concerns about your arrest and/or conviction record as it relates to your application, you may be called to appear before the Legislative & Regulatory Committee. If you are asked to appear but choose not to, your application may be denied.
3. Meetings of the Legislative & Regulatory Committee are open to the public. This application is a public record and subject to release.
