Administrator Tapson said the DPW Facility proposals were due Friday and four were received. Evaluation forms were given to the DPW Operations Manager, DPW Supervisor and Utility Director. It is planned to go to the committee with the evaluations next Monday.

Fire Advisory Board – the budget was reviewed and discussions on full-time positions continue Library Board – programs for children and adults are coming up, the DPW helped clean up mold in the basement

Chamber – new members were welcomed, the parade plans continue, the Travel Channel was in Elkhorn Recreation Advisory Board – at the last meeting the preliminary pool numbers were discussed, the Reindeer Run and Grinch Sprint needs volunteers

COMMITTEE REPORTS

Human Resources

Consideration and possible action of recommendation to approve Structural Adjustment to Compensation Plan and Adjust Utility Director and Assistant Finance Director/Treasurer to Midpoint, Beginning January 1, 2018

Alderman Myrin said the last time a structural pay rate adjustment took place was in 2015. Three employees in DPW would need adjustments and the City budgeted \$7,000 for the adjustments but the adjustments will be under budget. A resolution for this is under New Business.

Municipal Services & Utilities

Discussion on Update to E. Market Street Construction

Alderman Kluck said the contractor informed the City that more bad soils would need to be removed than originally thought. The cost to remove the soils will not exceed \$295,000 and is expected to be half that amount. The project is still under budget with the additional costs. City Engineer Calhoun said work is planned to start next week with grading in the late winter or early spring.

Discussion on Babe Mann Park Improvements

The committee agreed to add money to the 2018 Budget to get the plans for Babe Mann started.

PLAN COMMISSION

Recommendation to Approve Conditional Use Permit for Kunes Elkhorn GM, 1350 S HWY 67

Mayor Reynolds said Kunes wanted to include a quick oil change at the dealership and this is an expansion of their current franchise, not a separate business. *Motion (Myrin/Kluck) to approve the CUP for Kunes Elkhorn GM. Voice vote, all approved, motion carried.*
