Discussion on Waiving Fees for Community Center Rental

The Library Director was looking for direction on when to waive fees for renting of the Community Center. A local group that does free meals each month had asked to have the rental fees waived and the committee agreed to waiving fees. Discretion on when to waive fees for other events will be left to the Library Director.

Municipal Services and Utilities

Discussion on DPW Maintenance Facility Proposals Received

Four proposals were received and two stood out after staff reviewed them. These two firms will do a short presentation at a special MSU meeting on Wednesday. Alderman Myrin asked how staff arrived at the two firms. Administrator Tapson said four staff members reviewed and graded them. Some items looked at was past experience, having architects on-site readily available, amount of subcontracting of work and

responsiveness to proposal. Two firms received grades in the uppers teens while the top two were in the 30-40 point range. Committee members received copies of all the proposals.

Discussion on Creation of an Agreement with the Library

After discussion it was decided a formal agreement with the library would help with questions that arise, especially regarding repairs and sharing of costs. The MSU Committee will work on the agreement along with the library board president.
