PLAN COMMISSION

Recommendation to approve Certified Survey Map for Jean Brummel Trust for a 2-lot land division at W4057 Potter Road in the Town of Lafayette

Mayor Reynolds said the Plan Commission recommended approval of all the items on the agenda. *Motion* (*Shiroda/Young*) to approve the CSM for Jean Brummel Trust for a 2-lot land division at W4057 Potter Road. Voice vote, all approved, motion carried.

Recommendation to approve Certified Survey Map for Bielinski Investments, LLC for a 2-lot CSM located on the east side of Wisconsin St. between Harvest Way and Market St.

Mayor Reynolds said this was for a building downtown. *Motion (Myrin/Young) to approve the CUP for Elkhorn Auto Parts/Manjit Singh for a Liquor Store.* Alderman Shiroda said he would abstain from voting. Alderman Myrin asked if the loading and unloading can be limited to Washington Street; Mayor Reynolds said the Plan Commission discussed it and felt it was like all other businesses. *Motion (Myrin/Young) to amend by adding that loading and unloading will be restricted to Washington Street only. Voice vote, all approved with Shiroda abstaining, motion passed.*

Strand Contract Amendment No. 1 – Nettesheim Pumping Station Study An Amendment to extend completion date to February 28, 2019

DPW Manager Lindstrom said the horizontal data for the study is correct but the vertical/depth is not as accurate and Strand would like to wait for the accurate data before completing the study. *Motion* (*Dunwiddie/Young*) to approve extending the Strand Contract to February 28, 2019. Voice vote, all approved, motion carried.
