Ordinance No. 19-04 To Rezone 406 S. Wisconsin St. and the North Side of Clark St. between Wisconsin St. and Lincoln St. (First Reading)

Mayor Reynolds said this is so Wilson Farm Meats can put up a pavilion for cookouts and adding a parking lot area. There are plans to add two railroad cars in the future. *Motion (Shiroda/Myrin) to waive the first reading. Voice vote, all approved, motion carried. Motion (Shiroda/Myrin) to approve Ordinance No.* 19-04. Voice vote, all approved, motion carried.

Conditional Use Permit No. 19-05 for Wilson Farm Meats, 406 S. Wisconsin St. for "Planned Unit Development"

Change Order No. 3 for Department of Public Works Facility in the Amount of \$11,581

Public Works Manager Lindstrom said the Change Order includes three items and the Scherer contract included an allowance and there is still allowance available. *Motion (Myrin/Boggs) to approve Change Order No. 3. Roll call vote: Boggs, yes; Shiroda, yes; Young, yes; Myrin, yes. Motion carried.*

2019 Sanitary Sewer Cleaning and Televising Project

DPW Manager Lindstrom said this is being done in accordance with the DNR NON Notice and is in line with CMOM. The 2019 budget for this was \$30,000. He contacted WALCOMET to partner on the project to create a bigger project that would likely draw more bidders. WALCOMET will administer the project at no cost to the City only to include direct fees incurred for the City. Northern Pipe, Inc. was the low bidder. *Motion (Myrin/Boggs) to engage in project with WALCOMET in an amount not to exceed \$30,000. Roll call vote: Boggs, yes; Shiroda, yes; Young, yes; Myrin, yes. Motion carried.*
