In July the City's new website went online and has many new features that help keep citizens better informed and actively updated on City activities. The website features:

- A subscription service that allows you to sign up to receive the City's newsletter
 automatically delivered to your email. Other subscription services include
 notifications for City alerts, such as street closings, winter weather alerts or other
 emergency notifications.
- Street light out? Submit it to the City! Need a tree trimmed? Submit it to the City! An online fillable form let's you submit a request or concern to a specific department in the City. This feature allows residents to check on the status of their request/concern by entering the assigned 'ticket' number when revisiting the site, or a response can be received by email or phone call.
- Interested in renting a City facility? A calendar showing use and availability for each
 facility is on the website. This feature includes the ability to request to reserve a
 facility online.
- An **Elkhorn Business Directory** allows businesses to submit their information to be published on the website including the hours of operation, interactive map, and mobile-responsive images. This is a free service for City of Elkhorn businesses.
- The Fully Searchable Documents and Forms feature reduces the time residents spend scrolling through pages of information. Instead, all documents are searchable and the website has an Advanced Search Functionality that allows residents to quickly locate information.
- A new Projects page shows you the projects the City is currently working on and
 what stage in the process they are in. This page also helps commuters plan travel
 routes using the interactive mapping feature.
- The ability to sign up to receive **City Alerts and Notifications** sent to an email.

CITY OF ELKHORN TRICK OR TREATING

Trick or treating within the City of Elkhorn will take place Tuesday, October 31st from 5:00 p.m.—7:00 p.m.



The following is a list of safety tips to ensure that your trick or treat experience is a fun, safe experience for both yourself and your children:

- Do not allow a child to go "Trick or Treating" alone. Be sure older children TAKE A FRIEND and an ADULT accompanies young children.
- Be certain to accompany young children to the door of every house they approach.
- Children should be cautioned that they should NOT enter any home without permission from their parents.
- Make sure that all children carry a glow stick or wear reflective clothing. Facial masks should allow children to see and breathe properly and easily. All costumes and masks should be clearly marked as flame resistant.
- Parents should inspect all treats and dispose of anything that seems to have been tampered with, has been opened, or is not wrapped.

MULCH YOUR LEAVES INSTEAD OF RAKING & IMPROVE YOUR LAWN

Tired of raking leaves to the curb only to have the wind put them back into your yard, or your neighbors yard? (Or have your neighbors leaves end up in your yard?) Trees drop leaves at different times, so usually one raking doesn't get the job done either, then you may end up having to bag those late drop leaves—which can be back breaking work. Try something new, easy and quick this year! Mulch the leaves! It is clean and easy and adds back beneficial nutrients into your lawn. Just use your lawn mower and you will be finished in the same amount of time it takes to mow your lawn! And research conducted by Michigan State and Purdue University show that lawn quality is improved by mulching leaves into the grass. Give it a try this fall.

WINTER SIDEWALK CLEARING

A reminder to keep sidewalks safe this winter. Per the <u>Elkhorn Municipal Code</u>, the entire width of the sidewalk needs to be cleared of all accumulated snow and/or ice within 24 hours of the time that the snow or ice ceases to accumulate. If ice has accumulated, the owner is required to sprinkle the sidewalk with necessary material to accelerate melting or prevent slipping. Owners of property with sidewalks on two intersecting streets are required to remove snow and ice from the sidewalks of both streets, including the area bordering the crosswalk and the curb ramp. Do not plow, push, shovel or throw snow or ice onto any public streets, alley, sidewalk or public lands dedicated to public use except for parcels or lots where buildings are constructed within 5 feet of the street right-of-way and the sidewalks exist from the City right-of-way to the curb line. In such instances, it is permitted to deposit, in a nonhazardous manner, snow and ice from their sidewalks only onto public streets. If the City has to remove the snow and/or ice, the property owner will be charged without prior notice.

UTILITY DEPARTMENT NEWS

The Water Department will be doing the annual City wide hydrant flushing September 10—14 from 10 p.m. through 6 a.m. If you have any questions or concerns about the hydrant flushing, please call our office at 262-723-3138.

The Water Department continues to do cross connection inspections. The areas focused on are:

- Completing the Jackson Creek Subdivision We have only a couple of homes that we have not had access to.
- Completing the Green Acres Subdivision. We have just over 10 homes to gain access to for inspection.
- Completing the Pines Subdivision. We have over 30 homes in that subdivision left to do.
- Continuing our last area for this year with the areas between S. Lincoln St, E. Geneva, Harmony, and Centralia.

Cross connection inspections are required by the Department of Natural Resources (DNR) for all commercial and residential properties. The purpose of a cross connection inspection per Chapter 15.07 of the Plumbing Code "...is to protect the public water system from contaminants due to backflow of contaminants through the water service connection and to comply with the State mandate for maintenance..." Again, the DNR requires the inspections be completed because of the importance to protect the public water system. Failure to comply with the City and the DNR mandated program may cause a disconnection of water service until the inspection is completed.

The inspection takes approximately 15-20 minutes to complete. If you are in any of these areas and have not complied with the inspection access request, please call our office immediately at 262-723-3138 to schedule your appointment as soon as possible. We thank you in advance for your cooperation in ensuring safe drinking water for your family and the community.

Electric and water meter change outs continue. A couple of reasons requiring a water or electric meter change out is when the Billing Office flags the service for zero or unusual consumption. Electric meter change outs usually do not need an appointment and generally take just a few minutes. Water meter change outs require an appointment as Water Techs need access to the water meter inside your home. These appointments normally take about 30 minutes. During the water meter change outs, our Techs will also perform a quick cross connection inspection. Performing the cross connection inspection at the same time allows the department to get the inspections done without an additional appointment that could possibly cause an inconvenience for our customers.



We would like to suggest that customers who have contact information that has changed, please call the Billing Office at 262-723-2910 (option 3—Billing) to make sure phone numbers and contact information is up to date. The Operations Department has had a lot of service orders with wrong numbers or no phone numbers, making it more difficult to reach out to the customers in the event of meter or service issues.

BE SURE TO PAY YOUR UTILITY BILL THIS WINTER

Just a reminder for customers to continue to pay their utility bills throughout the winter months, so that a large utility bill on April 16th can be avoided. The bill

does not go away, it just accumulates with penalties.

Elkhorn Light & Water will not offer a DPA to a residential customer who is a tenant if any of the following criteria applies:

1. The residential tenant has greater than \$100 of account arrearages that are more than 90 days past due.

- 2. The residential tenant has defaulted on a deferred payment agreement in the past 12 months.
- 3. The residential tenant is responsible for account arrearages that were placed on any property owner's tax bill in the utility's service territory in the past 24 months.
 - 4. The residential tenant has a balance that accrued during the winter moratorium that is more than 80 days past due.

Anyone within any of the above categories will not be allowed to make a DPA in the future.

HOME ENERGY ASSISTANCE

Energy Services for Walworth County is now taking applications for home energy assistance. To qualify for assistance, households must have gross income for the three months immediately preceding the month of application that is at or below 60 percent of the state median income guidelines. Income guidelines for the 2017-2018 program year are: \$6,650.25 gross income 3 months prior to application for household of 1; \$8,696.25 for household of 2; \$10,742.50 for 3; \$12,788.75 for 4; \$14,835 for 5; \$16,881.25 for 6; \$17,264.75 for 7; and \$17,648.50 for 8.

To apply, applicants must provide Social Security numbers for all members of the household, most recent energy bill, photo identification and written proof of household's gross income for the three months prior to the application.

NOMINATION PAPERS FOR CITY OFFICES AT SPRING ELECTION

Anyone interested in running for the elected offices of Mayor or Alderman in District 3, 4 or 6 may obtain the necessary documents from the City Clerk's office beginning November 13, 2017 or on the City website. New candidates should file a <u>Campaign Registration Statement</u> as soon as intent to seek elective office is known and before funds are collected or spent. Candidates may begin circulating nomination papers on December 1, 2017. Signed nomination papers must be filed with the Clerk by 5 p.m. on Tuesday, January 2, 2018. Contact the City Clerk with any questions on running for office. The spring election will be held on April 3, 2018. If necessary, a primary election will be held on February 20, 2018.

2017 Fall Brush Collection Schedule

Weeks of October 16 & October 30 (Tuesday-Friday): East of Wisconsin Street Weeks of October 23 & November 6 (Tuesday-Friday): West of Wisconsin Street



RESIDENT GUIDELINES:

- No vines, rakings or roots (these may be brought to the Yard Waste Drop-Off Site, see below)
- Place cut ends, no larger than 6", facing direction of traffic traveling on street
- Of Do NOT co-mingle leaves with brush

All brush must be placed on the terrace by 7 a.m. on Tuesday of your brush pickup week. The public works crew will begin the route on Tuesday morning and will pick up your properly disposed of brush sometime during your scheduled week. Please do not place brush out after the crew has gone by, they will only go through the route once during the week. Parked cars must not block brush piles. If you hire a contractor for tree work, the contractor must take all debris.

2017 Fall Leaf Collection/Seasonal Burning

Fall Leaf Collection begins the week of October 16—October 20 (Monday—Friday) and ends the week of November 20—November 25 (Monday—Saturday). Due to the Thanksgiving holiday falling within the last week, the Thursday route will be picked up on Friday and the Friday route will be picked up on Saturday. The City is divided into 5 sections; each section has an assigned week day for pickup. Please see the map on page 7 or the City's website for your pickup day. Advanced Disposal is contracted to conduct the leaf collection.

LEAVES WILL ONLY BE COLLECTED DURING YOUR LEAF COLLECTION DAY

- Please rake leaves into the street at least 12 inches from the gutter, the leaves will be picked up off of the street
- Leaves MUST be in the gutter no later than 7 a.m. of the scheduled pickup day
- O NOT combine brush with leaves or place leaves in bags or boxes

SEASONAL LEAF BURNING is allowed between October 1st and November 30th without a permit

- Ics Burning Shall occur on the resident's property at a minimum distance of 25 feet from any occupied dwelling
- Os NOT burn on streets, sidewalks, terraces, or any other location within the public right-of-way
- NO burning when wind is in excess of 10 miles per hour
- Burning permitted between the hours of 8 a.m. to 8 p.m.



- G Tightly bundle tree limbs and branches no greater than 3 inches in diameter and 4 feet in length with twine (no wire or nylon)
- 30 gallon paper bags or dry cardboard boxes not larger than 3 X 3 feet
- NO stumps, roots or shrubs with intact root balls
- og NO plastic bags!

Items to be Recycled

Have your trash and recycling out to the curb by 6:00 a.m.

Cardboard (flattened)

Clean cardboard only; broken down and flattened, and placed inside the cart.

Aluminum

Aluminum beverage cans only. No food trays, aluminum foil, etc.

Glass (bottles and jars)

No window glass, light bulbs, TV tubes, drinking glass, etc.

Tin and Bi-Metal Cans

Soup, vegetable, juice cans, etc. All cans must be rinsed out completely.

Plastic and Aseptic Containers

This includes plastic bottles with threaded caps with recycling symbol <u>1</u> through 5 and 7. Juice and milk cartons are also accepted. *All plastic bottles must be rinsed out completely.*

Look for on the container.

Newspapers, Magazines, Office Paper

Glossy inserts, catalogs, mail circulars, phone books, paperback books, school papers, cereal boxes, envelopes, wrapping paper, etc.

Place your recyclables in the recycling containers provided. These containers are to be left with the residence if you move.

Please keep your recyclables separate from your other garbage and easily accessible. Keep carts at least three feet apart and away from other objects (mailboxes, light poles, etc.)

City of Elkhorn's Recycling Collection is every other week, the same day as weekly trash services

- \otimes NO MEDICAL WASTE—i.e. needles, rubber gloves, oxygen tubes, IV bags, etc.

SPEEDING-SLOW DOWN FOR EVERYONE'S SAFETY



One of the more frequent concerns we hear from residents is that of vehicles speeding in their neighborhood, which not only causes concerns for their personal safety and that of others but the associated problems of noise. Often what follows is a recommendation to erect stop signs to slow motorists or install more speed limit signs, which people mistakenly believe will solve the problem. The police department's initial response is to evaluate the concern and we do this by ensuring the speed zone is appropriately posted according to DOT standards, reviewing crash statistics, as well as collecting speed data

in the area of the concern. Estimating vehicle's speeds from a stationary position is often difficult, even for those who have been trained, and quite often the results of the data collection reveal that overall vehicle speed is not what it was thought to be. Nevertheless, from that data we are able to glean a wealth of information to enhance our enforcement efforts. From the data collected we are able to determine what is referred to as the 85th percentile speed, which is important as the 85th percentile represents the speed that 85% of motorists are traveling at or below. Further, studies have shown that the 85th percentile represents the speed that motorists believe is safe to travel at and is a factor to determine what the speed limit should be posted for. In addition, the data will guide our enforcement efforts as it will provide the days and times when the problem is more prevalent. From this information, the police department can focus its resources more effectively and efficiently and look to address the driving behavior of those motorists that are most likely to cause traffic crashes.

Please keep in mind that speed was a factor in nearly 1/3 of the fatal accidents in Wisconsin in 2014 and crashes are more likely to occur in urban areas. The police department is asking for your cooperation in enhancing traffic safety by slowing down for everyone's safety. WINTER PARKING REGULATIONS

The parking or leaving of any vehicle on any street in the City is prohibited when the National Weather Service has issued any of the following winter storm messages which are in effect for our area: winter weather advisory, winter storm warning or blizzard warning. These parking restrictions will remain in effect for a period of 12 hours after the expiration of the winter storm message. Failure to comply may result in the removal of any vehicle parked in violation of this, and the vehicle owner shall be responsible for the cost of towing, storage and any other charges in connection with its removal in addition to the penalties set forth in the city ordinance.

The City offers an **alert notification reminder** when National Weather System winter storm messages prompts winter parking regulations. To sign up to receive text notifications to your cellular phone of the start of parking restrictions in the City, text this message: **@elkhorndpw** to: **81010** (this service is free, however, texting rates may apply). You can opt-out of messages at any time by replying: **@LEAVE**.

WALWORTH COUNTY CLEAN SWEEP HOUSEHOLD HAZARDOUS WASTE DISPOSAL

The Walworth County Public Works Department is sponsoring a Clean Sweep Program Friday and Saturday, October 6th & 7th. This event will help household residents, businesses, schools and municipalities properly dispose of damaged, banned, unusable or unwanted products that contain volatile chemicals.

Clean Sweep services are provided free-of-charge to household residents who may drop off items without an appointment at the following times and locations:

Friday, October 6th - 3:00 p.m. to 5:00 p.m. City of Delavan, 490 Richmond Rd (Cty Hwy M & P), Delavan and City of Whitewater Public Works Complex, 150 East Starin Rd, Whitewater

Saturday, October 7th - 8:00 a.m. to Noon Walworth County Public Works Department, W4097 County

Road NN, Elkhorn

Clean Sweep program services are also available to any business, municipality, school, or other service provider that generates small amounts of hazardous waste, and classifies as a Very Small Quantity Generator (VSQG) according to DNR standards. VSQG program participants pay for product disposal but the cost is significantly less than contracting individually for this service. The program is cost-effective and convenient. Anyone interested, must pre-register and provide a list of products they want to dispose of by Tuesday, September 26th.
