The City of Elkhorn enters a new era in government. The Council has new Mayor and three Aldermen.

to accept his elected position for the Fourth District. The new Council is required to fill the vacancy by appointment.

CITY'S CAPITAL IMPROVEMENT PROGRAM HAS WIDE RANGE OF PROJECTS IN 2002

The City's adopted Capital Improvement program calls for a wide range of projects during 2002.

A major road project is E. Geneva Street. After years of discussion and debate, the project includes reconstruction of the street from



its intersection at Lincoln Street to the en-

the Elkhorn Area High School. All utilities will be replaced with a new street being constructed with new curb and gutter.

The street will be closed except for local traffic after June 7 and will be com-

pleted by August 30. The project cost is \$1.25 million

The South Broad Street road project, which is part of the downtown renovation, will likely begin in July. The street will be reconstructed from W. Walworth St. to Rockwell. A boulevard is in the plans. One will be located in front of City Hall, others will be constructed after the Fire Station entrance. In addition to the aesthetic value of the boulevards, it is hoped that it will eliminate the uturn violations that occur in front of City Hall.

In addition to the street projects, other CIP projects include construction of a Parks & Recreation Office/

Activity Center; redevelopment of play areas at Sunset Park; and the expansion of Matheson Memorial Library.

Beyond the current year, the CIP targets through 2006 such projects as: completion of downtown street improvements; development of the "White River" Bike Trail; water plant upgrades; a second phase of street reconstruction; and completion of the Sunset Park redevelopment plan.

This rather aggressive schedule of activities may be subject to considerable modification in light of anticipated reductions in State shared revenues.

Employee spotlight

The City welcomes Joel Christensen, its new Police Chief. And, says goodbye and thank you to Chief John Giese after 30 years of service to the City.

Chief Christensen worked up through the ranks of the Elkhom Police Department. He was hired in 1989 as Patrol Officer.

"I want to expand the Community-Orientated Policing Policy," Christensen said of the goals he as set for himself and the department. Interacting with the citizens is important to him. The residents of Elkhorn can expect to see Patrol Officers out of their cars, walking the streets and interacting with the public.

Christensen plans to develop a crime prevention program to help businesses evaluate their specific needs, such as alarm systems.

An emphasis on the youth through such programs as Counteract, similar to DARE, will continue to be a strong focus of the department.

Like Chief Giese, Chief Christensen has his door open to the public.

NEW PROCEDURES, FEES FOR FACILITY RENTALS

The Parks and Recreation Department has established new Facility Rental Fees and procedures.

Rental fee for any facility, except the Municipal Pool is \$50 for residents of Elkhorn and \$75 for non-residents. Non-residents are anyone living outside of the City limits.

A deposit of \$25 is required and will be re-

funded if the facility and/ or park area is in its original state after the event and the key is dropped off by 4:00 p.m. on the next working day.

If the event is expecting more than 50 participants, a \$25 fee for garbage disposal is charged.

To serve beer, a \$50 permit is required. The permit must be approved by the Parks and Recrea-

tion Director and is confined within the shelter or a fenced in area only at the Lions Den and Harris Park. If beer is going to be sold, a Class "B" picnic license is required and must be obtained from the City Clerk, 30 days in advance of the event.

RENT THE MUNICIPAL POOL FOR A PARTY

Want a great way to cool off on a hot summer's day and bring 50 of your best friends? Why not rent the Municipal Pool?

When the municipal pool, located at Sunset Park, is not being used for City Parks and Recreation programs, citizens can rent it for large groups.

The Municipal Pool Rental Fee structure is as follows:

50 people or less

Resident \$50/hour Non-resident \$75/hour

51—75 people

Resident \$65/hour Non-resident \$90/hour

76 people or more

Resident \$80/hour Non-resident \$104/ hour

(Non-residents live outside City limits)

HOW DOES THE STATE BUDGET IMPACT ELKHORN

Much has been written and said over the past two months in regard to Governor McCallum's proposed "Budget Repair Bill", but the outcome of the debate remains uncertain at this time.

What does seem certain, though, is that a reduction in State aid to municipalities is inevitable; leaving only the severity of the loss in question. It appears likely that one of several compromise plans, which are less sever in their impact than the Governor's plan, will be implemented.

Depending on which of these plans is adopted by the legislature, the City

would experience a revenue reduction in 2003 between \$190,000 and \$265,000. Additional shared revenue cutback contemplated in 2004 could further reduce the City revenue stream by another \$100,000.

Although the specifics of the legislature's plan are not known, the city staff has been looking at measures that may be taken in response to the anticipated revenue loss. The exact nature of such actions is yet to be finalized, but it is likely that a combination of service modifications, expenditure cutbacks and user fees will be required.

LIBRARY SEEKS SUPPORT FROM AREA RESIDENTS

The Library Board is actively seeking pledges and donations to build the library large enough to meet the needs of Elkhorn and the surrounding towns caused by their growing populations. The City has budgeted \$2.5 million dollars toward the new addition of the Matheson Memorial Library and Community Center. The project costs exceed that amount by \$750,000 to \$1 million depending on the final cost of construction.

Towns of Sugar Creek, La Grange, Lafayette, Geneva and Delavan have been asked to participate in the building project. They represent 40% of the library's circulation.

The major focus of the project is the youth services library which occupies 685 square feet of space. Today's standards call for 1,430 square feet. The present

story hour area is not handicapped accessible. Adults will find more than two easy chairs to sit in and read their newspaper. A tech center, expanded reference and non-fiction area, and CD listening sessions are included. The new Community Center which is part of the library building houses a room for 125 people, a smaller one for 25 and a kitchen. It will be available for rental by the Parks and Rec. Dept.

When your sewer backs up, please call City Hall. The Public Works Department needs to know and so does the administrative office. It could possibly be a liability claim. The procedure for such claims begins with notification from the property owner to City Hall at 723-2219. After hours emergency number is 723-3229.

A claim will be filed with the City's liability insurance carrier.

A representative from the insurance carrier will

investigate the matter and contact you with any questions they may have concerning the claim. Once the investigation is complete, a decision will be made by the carrier as to whether the City is liable or not. The procedure is the same if an injury occurs on City property.
