City Administrator message

The City has been abuzz with activity since my update last spring, especially with economic development. Starbucks and Taco Bell recently opened, and Anytime Fitness broke ground on a gym that will be part of a new three-tenant commercial building on N. Wisconsin Street. There have also been several construction projects in the business park, including expansions by Pregis (30,000 SF), Elkhorn Electropolish (4,875 SF), and MaxPax (83,925 SF). In addition, Project Veteran Muscle Gym is in the process of relocating their facility from Lake Geneva to Elkhorn.

Since last spring there has also been significant progress on the proposed Creekside Community Development, which is a mixed-use residential and commercial development planned near the intersection of S. Lincoln St. and I-43. The City completed the project plan amendment and boundary adjustment for the tax incremental district. We also negotiated a proposed development agreement with the Creekside developers, who submitted their General Development Plan for review by the Plan Commission.

Economic development hasn't been the only area of activity since last spring. As many of you probably noticed, the City has been working on road improvement projects on S. Wright St., E. Market St., and E. Centralia St. The largest of these projects, E. Centralia St., should be done by November.

The City has been planning for other infrastructure projects, including improvements to the water system, such as finalizing designs for the Lakeland Water Treatment Plant rehab and the Northeast Water Treatment Plant sewer extension. To help fund water operations, the City submitted an application to the Public Service Commission to adjust water rates in the coming year. The City will keep the public updated when we receive more information from the PSC about potential rate increases.

Hopefully you have had a chance to enjoy the park improvements around the City. The new Babe Mann Park shelter was finished in late May and has been popular. The City partnered with the Elkhorn Rotary Club to install a kayak launch and fishing pier at Babe Mann Park as well as to install picnic tables. The City is also partnering with the Rotary Club to add benches and more trees to Babe Mann Park, which should be coming this fall. The City installed toddler playground equipment at Tasch Park using a donation from the Kiwanis Club. Since last spring the City has also been finalizing a partnership with a private property owner to provide a garden/park that will be open to the public near the Chamber building, using funds from a WEDC Vibrant Spaces Grant. The City also completed the purchase of 39.06 acres of open space from the County that had been acquired through tax forfeiture.

The City has been trying to improve services in other areas as well. The Common Council recently selected Badgerland Disposal, LLC, an LRS (Lakeshore Recycling Systems) company, as the City's new provider of residential solid waste collection and recycling services. LRS will take over these services on January 1, 2024. More information will be coming about the transition from Waste Management.

In an attempt to better recruit and retain City employees, the City hired an HR generalist in early September. It's our hope that this position will help the City fully staff public safety departments, especially the Fire Department. It's also our hope that the HR generalist will assist the City in modernizing personnel policies and coordinating trainings for City staff.

We are now in the middle of budget season, and the City is utilizing new capital improvement planning and budgeting software that will allow the City to not only better plan for future capital and budget needs but also provide the public with more information about how taxes and other revenues are being used.

Elkhorn is a wonderful community with a bright future. Our focus at the City is on providing the best quality of life possible for businesses, residents, and visitors. This is the mission that guides us, and we welcome the opportunity to work with community partners to make this happen.

2023 FALL LEAF COLLECTION

With Waste Management's contract expiring the City will be transitioning to perform leaf collection internally with staff from the Public Works Department.

The City of Elkhorn offers residents curbside leaf collection services each spring and fall. Spring Leaf Collection runs the first two weeks of April. Fall Leaf Collection usually runs for six weeks commencing on the third Monday of October (weather pending). Exact start date and duration of collection varies depending on the season and weather.

The City's Public Works Department will strive to collect as long as the season allows. Please look for announcements and updates on our Website and Facebook page regarding commencement and final day of collection services for the season. You can also contact our office at 262.723.2223.

Leaves raked out after the deadline will not be collected. Residents can mulch the leaves into the lawn or bring them to the City's Compost Site located at 401 E Centralia Street, at the dead end of Getzen Street. The City's Compost Site is always an option for residents to dispose of leaves, yard waste (such as flowers, pumpkins, garden trimmings and weeds), brush and branches. It is open seven days a week (8:00AM to 8:00PM) from April 1st through the Sunday after Thanksgiving.

During leaf collection services, rake leaves into the street at least 1-foot away from the curb to allow storm water to pass and prevent flooding. The 1-foot gap also mitigates concerns with equipment and the curb being damaged.
Do not combine brush with leaves, the City offers a separate brush collection operation. Do not include pumpkins, litter or yard waste such as flowers, garden trimmings and weeds in leaf piles. Do not place leaves in bags or boxes.

Prior to Fall of 2023, the City was divided into 5 sections, one section for each day of the week. This day coincided with refuse collection which makes collection challenging. In addition, some of the daily routes are leaf heavier than others with mature trees. Assigned routes do not allow for flexibility with inclement weather and other operations occurring at this time of the year. For example, during the beginning of the season it is possible we could clear all five routes within three days. During heavier times, it may take all five days or possibly longer. Due to these challenges, the City will no longer maintain an assigned day per each daily route. Place leaves when you are able throughout the Spring and Fall Leaf Collection schedule as detailed above, you will no longer have an assigned day. Leaf collection operations will cycle through the City systematically with the goal of clearing it weekly.

LEAF BURNING IS NOT ALLOWED IN THE CITY

The City of Elkhorn is a permitted MS4 community as defined by the State of Wisconsin Department of Natural Resources (WDNR). With that in mind, storm water from Elkhorn, which travels to the Rock River and Upper Fox River, is being monitored by the WDNR. In order to stay compliant and protect the environment we maintain ordinances and policies to keep grass, dirt, branches, yard waste and garbage off the street. This prevents said debris from clogging inlets and ending up in our tributaries.

We ask that you do your part and follow said policies and ordinances.

Be sure to pay your utility bill this winter

Just a reminder to continue to pay your utility bill throughout the winter months. The bill does not go away, it just accumulates with penalties. Elkhorn Light & Water will not offer a deferred payment agreement (DPA) to a residential customer who is a tenant if any of the following criteria applies:

1. The residential tenant has greater than \$100 of account arrears that are more than 90 days past due.

2. The residential tenant has defaulted on a deferred payment agreement in the past 12 months.

 The residential tenant is responsible for account arrearages that were placed on any property owner's tax bill in the utility's service territory in the past 24 months.
 The residential tenant has a balance that accrued during the winter moratorium that is more than 80 days past due.

If any of the above criteria applies you will not be allowed to make a DPA in the future.

Who is eligible?

Your household may be eligible for the Wisconsin Home Energy Assistance Program (WHEAP), Weatherization Assistance Program, and the HE+ Program Services based on a number of factors. If your household gross income (before taxes and other deductions) is less than the amount shown on the chart below, you may be eligible. You can apply at your local WHEAP agency, online, or by phone.

Winter Parking



The parking or leaving of any vehicle on any street in the City is prohibited when the National Weather Service has issued any of the following winter storm messages in effect for our area:

winter weather advisory, winter storm warning or blizzard warning. These parking restrictions will remain in effect for a period of 12 hours after the expiration of the winter storm message. Failure to comply may result in the removal of any vehicle parked in violation of this, and the vehicle owner shall be responsible for the cost of towing, storage and any other charges in connection with its removal in addition to the penalties set forth in the city ordinance.



Winter Sidewalks

A reminder to keep sidewalks safe this winter. Per the Elkhorn Municipal Code, the entire width of the sidewalk needs to be cleared of all accumulated snow and/or ice within 24 hours of the time that the snow or ice ceases to accumulate. If ice has accumulated, the owner is required to sprinkle the sidewalk with necessary material to accelerate melting or prevent slipping. Owners of properties with sidewalks on two intersecting streets are required to remove snow and ice from the sidewalks of both streets, including the area bordering the crosswalk and the curb ramp. Please do not plow, push, shovel or throw snow or ice onto any public streets, alley, sidewalk or public lands dedicated to public use except for parcels or lot where buildings are constructed within 5 feet of the street right-of-way and the sidewalks exist from the City right-of-way to the curb line. In such instances, it is permitted to deposit the snow and ice, in a nonhazardous manner, from their sidewalks only onto the public streets. If the city has to remove the snow and/or ice, the property owner will be charged without prior notice.







In the event of a fire emergency during the winter, could firefighters find the hydrant near your home?

The City of Elkhorn encourages residents to be aware of the fire hydrants near their home and keep snow shoveled away from it during the winter season.

Clear a path approximately 3 feet around the hydrant. Please consider helping a neighbor who is elderly or has a medical condition by shoveling out a hydrant in front of their home. This act of kindness will benefit the entire neighborhood.

Keeping fire hydrants clear gives the Fire Department room to work with the hydrant should the need arise.

Water is the principal agent used by the Fire Department to control and extinguish fires. Delays in locating and hooking up to a fire hydrant can seriously hamper a fire suppression operation, raising the risk of injury and possibly resulting in additional property damage.
