

ADVERTISEMENT FOR BIDS

Sealed bids, for the City of Elkhorn "2018 Elkhorn Streets Project" Contract, will be received by the **City of Elkhorn, at City Hall, 9 S. Broad Street, P.O. Box 920, Elkhorn, Wisconsin 53121**, until **Thursday, April 19, 2018, at 9:00 am, central time**, at which time they will be publicly opened and read aloud in the Council Chambers at this location. If a Bid is received by mail or other delivery system, the sealed envelope containing the Bid shall be enclosed in a separate package plainly marked on the outside with the notation "BID ENCLOSED – 2018 ELKHORN STREETS PROJECT." The work includes furnishing of all materials and equipment and performance of the following work, per the Plans, Specifications and Contract Documents (PS & CD).

The Base Bid work for the above contract includes: Improvements to Proctor Drive and Westlawn Avenue (from west end to 401 Westlawn) include replacement of existing pavement using 8-ft wedges and a 2-inch overlay. Hazel Ridge Road improvements include replacement of existing pavement by pulverizing and overlaying. Westlawn Avenue and Spencer Lane improvements include full reconstruction from 401 to 301 Westlawn Avenue and Spencer lane, respectively., as well as new sidewalk on Westlawn Avenue and Edgewood Avenue. Improvements to the Matheson Memorial Library parking lot include a 2-inch mill and overlay for the majority of the lot and full reconstruction of a portion of it, as well as new pavement marking and curb and gutter. Utility work across STH 67 includes open cutting sanitary sewer and water main across the street to serve a new development. Major work items and approximate quantities for which bids are requested include: 2620 tons HMA pavement, 1700 lineal feet of concrete curb and gutter, 8320 square feet of concrete sidewalk, 2220 tons of base aggregate dense, 430 lineal feet of reinforced concrete storm sewer pipe, 605 lineal feet of PVC sanitary sewer, and 125 lineal feet of water main pipe. The project also includes concrete driveways, catch basins, manholes, pipe underdrains, sawing asphalt and concrete, pavement marking, excavation common, landscape restoration, traffic control, and erosion control.

Also included is a mandatory alternate bid for a pulverize and relay of Clark Street from S. Wisconsin Street to S. Lincoln Street (STH 67). The alternate bid work includes pulverizing approximately 17,500 square feet of roadway and overlaying with 4 inches of HMA.

A Bidders qualification statement form will be issued with the Bid Documents. The Bidders Qualification Statement form must be completed and submitted in a sealed envelope at the time of Bid submittal. No bids will be accepted from any Bidder who has not submitted a Bidders Qualification Statement form. Contractors who have submitted prequalification statements to the City of Elkhorn, for this calendar year and for work specific to this project, shall state this on their Bidders Qualification Statement form and prequalification forms will be reviewed. The Owner reserves the right to reject the bid of any Bidder who has been determined to be unqualified.

As a part of their Bids, Bidders shall submit a full and complete list of: 1) all of the proposed Subcontractors, and 2) the class of work which each will perform. The selected Contractor shall not alter this list without the written consent of the City.

The PS & CD require that the selected Contractor and Subcontractor(s) furnish a Certificate of Insurance.

Bidders shall submit Bids on blanks prepared for that purpose and shall state prices in writing and in figures. Use the form contained in the PS & CD. Bidders should pay attention to the requirements for Bid signatures, as set forth in Bid Security. Bidders may not withdraw their Bids within the 60-day period after the date of the Bid Opening.

The City will only consider Bids from Bidders who accompany them with bank money order, a Bid Bond, or a qualified certified check, payable to the City of Elkhorn, in the amount equal to 5 percent of the Bid. This requirement serves to guarantee that, if the City accepts the Bid, the selected Contractor will execute and deliver the proper Contract Agreement and Bonds within 15 calendar days after the Notice of Award by the City. Failure to return these documents within this prescribed time will result in forfeiture, to the City of Elkhorn, of the selected Contractor's cash, Bid Bond, or cashier's check, as liquidated damages.
